Subj.: procedure of registration and reviewing of manuscripts
submitted to "Dvigatestroyeniye" magazine for publication

In compliance with current regulation of editorial board of scientific and technical magazine "Dvigatestroyeniye", hereinafter referred to as "magazine", approved by General Manager of JCS CNIDI-ECOSERVICE, magazine publisher, on 01.02.2006, and Order of the Russian Ministry of Education and Science Nr. 793 dated 25.07.1014 "On-notice approval of the list of reviewable scientific editions wherein scientific results of dissertations for a degree of Candidate of Science and Doctor of Science shall compulsorily be published, and requirements to reviewable scientific editions to be qualified for inclusion in the list of reviewable scientific editions wherein scientific results of dissertations for a degree of Candidate of Science and Doctor of Science shall compulsorily be published",

HEREBY I PRECEPT:

To establish procedure of registration and reviewing of manuscripts submitted to "Dvigatestroyeniye" magazine for publication as follows:

1. Responsibility for registration of manuscripts submitted to "Dvigatestroyeniye" magazine for publication lies with issuing editor. Manuscripts submitted to "Dvigatestroyeniye" magazine for publication are qualified for registration if they are compatible with magazine's profile & topical area, and meet the requirements set forth in "To the attention of authors" section of the magazine, and at our site <http://rdiesel.ru/DVIGATELESTROYENIYE/VA>. When manuscript submitted to "Dvigatestroyeniye" magazine fails to meet the above requirements, author(s) shall be notified in written of needed correction of the manuscript in question in two weeks since its reception.

2. Responsibility for organization of manuscripts' reviewing lies with scientific editor.

2.1. Manuscript prepared on author's own initiative shall be sent for reviewing to a specialist in discipline compatible with publication subject and having scientific degree of candidate or doctor the following technical science. Furthermore, it shall be sent for reviewing to one of editorial board members (verbal opinion is acceptable).

2.2. Manuscript intended for publication as containing results of planned research program carried out by a scientific (educational) institution and recommended for publication by scientific and technical council of the above scientific (educational) institution shall be sent for reviewing to one of editorial board members.

2.3. Decision on manuscript publication is with editorial board or editor-in-chief, taking account of reviewing results and opinion of the editorial board member.

2.4. In case opinion of the reviewer or the editorial board member is negative, copy of reviewer's opinion in written (anonymous) or notification of needed corrections based on reviewer's opinion (in written) shall be sent to the author(s) in two weeks since the reception of the manuscript in question. Corrected manuscripts shall be sent for repeated reviewing according to procedure established by this Order.

2.5. In case scientific discussion emerges between author(s) and reviewer that might be of interest for engine building specialists, the manuscript in question and reviewer's opinion may be published in "Hypotheses and discussions" section of the magazine.

2.6. Written copies of testimonials (opinions) shall be stored in magazine archive for five years. Responsibility for manuscript registration and storage lies with issuing editor.
